

MOTORCLASSICA PASSPORT REGISTRATION PROMOTION-TERMS and CONDITIONS

INTRODUCTION

- 1 Information on how to enter and about prizes form part of these Terms and Conditions. Participation in the Motorclassica (“**Show**”) Passport Registration Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions.
- 2 The Show is held from 12 – 14 October 2018 at the Royal Exhibition Building, Melbourne. The Promotion is comprised of 2 draws in relation to the Show: (1) the AGP Draw and (2) the BRM draw (3) the Mumm Draw.
- 3 The Promoter is Exhibitions and Trade Fairs Pty Limited, ABN 72 101 130 527) (“**Promoter**”) of Level 1 Unit 4, 20-26 Sabre Drive, Port Melbourne VIC (“**Promoter’s Offices**”).

ELIGIBILITY

- 4 Entry is open to Australian Citizens and Permanent Residents aged 18 years and over, excluding those residing in NSW, NT, ACT and SA (“**Eligible Entrants**”). Employees of the Promoter or its associated entities and agencies and their immediate family members are not, however, permitted to enter.

PROMOTION PERIOD

- 5 The Promotion commences when the Show opens at 9am AEST Friday 12th October 2018 and ends at 5 pm AEST on Sunday 14th October 2018. (“**Promotion Period**”).

HOW TO ENTER

- 6 You can enter each draw once **only**. To enter you must register your details (including your name, email, address and telephone number) at a registration passport station at the Show. The location of the passport stations is set out in the Show Guide.

- 9 The draws will be conducted electronically and will take place at 10 am 22 October 2018 at the Promoter’s Offices. The first valid entry drawn in each of the draws will win.

WINNER NOTIFICATION

- 10 Winners will be notified in writing by email & phone within 14 days of the draw. Prizes must be claimed within **one month**. Winner’s names (once verified) will be published on www.motorclassica.com.au on the date of the draw.

UNCLAIMED PRIZES

- 11 A draw for any unclaimed prize will take place at 10 am on 22 November 2018 at the Promoter’s Offices - subject to any directions of a regulatory authority. Winners (if any) will be notified by e mail & phone & their names published on www.motorclassica.com.au on the date of the draw.

PRIZE COLLECTION/DELIVERY - OTHER DRAWS

- 12 Subject to paragraph 14, the Promoter will contact each winner to obtain a delivery address in Australia and their prize will be delivered to this address by the Prize Supplier in accordance with the Prize Supplier’s usual delivery protocols or arrangements.

PRIVACY

- 13 The Promoter will collect personal information (“**PI**”) from each entrant in order to conduct this Promotion and may disclose this PI to regulatory authorities & relevant third parties, including its related entities, agents and the Prize Suppliers. The Promoter & these third parties may use this PI for promotional, marketing, research and profiling purposes (including sending electronic messages or phoning the entrants) in accordance with the law and their respective privacy policies. - 16 If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter may, to the fullest extent permitted by law & subject to any written directions from a relevant authority, modify, suspend, terminate or cancel the Promotion, as appropriate.
- 17 These terms contain prize offers from Prize Suppliers who are not related companies of the Promoter. Subject to any applicable law which cannot be excluded, the Promoter makes no warranties or representations regarding the availability, quality, accuracy, merchantability or fitness for purpose of the goods or services offered as prizes. Your entering this Promotion and obtaining of goods or services from Prize Suppliers is at your own risk. All prize information and other information concerning the prizes is provided by Prize Suppliers and we advise you to confirm pricing and other details with the Prize Suppliers for the most accurate information about personal and other expenses, availability, travel risks.
- 18 You indemnify the Promoter against all liability, loss, damage, cost and expense arising from or relating to your obtaining goods or services from Prize Suppliers offering prizes in this Promotion.
